Michigan population

Initial census data bared; Michigan, 9 other states lose US Congress seats

Michigan lost one US congressional seat due to a decrease in its population. This was learned from the initial data released recently by the Census Bureau and made available to the Council of Asian Pacific Americans (CAPA) by the Asian American Center for Advancing Justice. The data were culled from the statistics gathered during the census survey conducted last year.

The initial data also showed that the US population is now 308,745, 538, up by 9.7 percent from the 2000 population.

The exact figure on the decrease in Michigan's population was not immediately disclosed, but Michigan is included in a list of 10 states that have lost seats in the US Congress due to reduction in their population.

Commission to hold forum on bullying of kids on Jan. 25

LANSING – The Michigan Civil Rights Commission (MCRC) announced that it will hold a public forum on bullying of children on January 25, 2011 at 4-6 p.m. in room L-150 of Cadillac Place at 3054 W. Grand Boulevard, Detroit.

During the public forum, the commission will discuss and take public comment on bullying of kids. A number of guest speakers with expertise on the bullying problem and related issues will be present.

The general public is urged to attend the forum, especially those who wish to provide testimony on bullying.

Discrimination of women of color rampant, Brooks say

Findings of new studies confirmed that women of color, including Asian-American women, are and have always been at the socio-economic bottom of the US, far below men of color and far below white women, Suzanne Brooks, president and CEO of the International Association for Women of Color Day, reported. In a recent conference, Brooks also reported:

The nine other states in the list are Illinois, Iowa, Louisiana, Missouri, New Jersey, New York, Ohio, Pennsylvania and Massachusetts. New York and Ohio lost two seats each, and the seven others lost one seat each.

Michigan is also in a list of five states with the slowest population growth. The four others in the list are Rhode Island, Louisiana, Ohio and New York.

The initial data likewise showed that eight states have gained congressional seats due to increases in their population. These are Arizona, Florida, Georgia, Nevada, South Carolina, Texas, Utah and Washington. Texas gets four more seats, while Florida gains two.

“There are still many state governments in the US in which there have never been any women of color in their legislatures. Asian-American women, like other women of color, are subjected to both racism and sexism and that includes sexism from within Asian-American communities and racism by

“Women of color have the high rates of suicide, with Asian-American women having the highest rate.

“In the US Congress, there have been only four Asian-American women representatives in the House of Representatives -- all of them Japanese-Americans, three of them from Hawaii. “Only Doris Matsui who replaced her husband has been in the House of



white women.” She said she is working on a new book, *The Constructive Extermination of Women of Color: The Consequences of Perpetual Socio-Economic Marginalization*, “because women of color are dying at the highest rate from every curable disease in the US.”

Brooks also noted that “women of color have been targeted by predatory mortgage practices to the extent that we have received 48 percent of the foreclosures while making up less than 16 percent of the population, yet these issues go unaddressed.

“Women's groups claiming to support all women, but dominated by white women have photos of women of color on their websites but refuse to address the intersection of racism and sexism which only women of color experience.

“If women of color continue to die unnecessarily, then our cultures will suffer as the women in all of them are the historical carriers and teachers of the cultures to our children.

“There will still be some women of color whose fathers are men of color and whose mothers are not. In those instances, the mothers will only be able

to pass on their own cultures, not those of Asian Americans, Native Americans, African Americans, Pacific Islanders and Latino Americans.

“Thus, the constructive extermination of women of color -- as we have been through the ages, means ultimately the comprehensive changing of the cultures of people of color, making all groups easier to manipulate and control.”

Korean kids contest - Essay-writing contest for Korean children

The Michigan Korean-American Chamber of Commerce Foundation (MKACCF) announced it is sponsoring a Sol Nal essay-writing contest.

The participants could win cash or gift certificates. The winners will receive their prizes at the KACE's 2011 Year of the Rabbit Sol Nal party scheduled on February 6 at the Korean United Methodist Church of Metro Detroit.

Grades K-3 participants are asked draw a picture of their favorite Korean meal.

Grades 4-7 participants are asked to write an essay on “Why I'm proud to be Korean American?”

Grades 8-12 participants are asked to write an essay on “50+ Years of Korean immigration to the US: Background and Impacts.”

The prizes include seven \$20 Toys R Us gift cards for Grades K-3; five \$30 cash prizes for Grades 4-7; and three \$50 cash prizes for Grades 8-12.

The essays must be typed in 12-point font, double - spaced, between 3 - 4 pages in length.

Drawing must be on 8.5” X 11” paper. Drawing and essays can be folded.

The participants are to give their names, age and phone number.

Rites for Vincent Chin marker held in downtown Ferndale

Chin's legacy is a changed legal system protecting Asians and other minorities

FERNDALÉ, Michigan -- The memory of Vincent Chin and the birth of the Asian American Civil Rights Movement in downtown Ferndale 27 years

ago became an official piece of the city's historical landscape on Dec. 22, 2010 with the installation and dedication of the State Bar of Michigan's 34th Legal Milestone marker.

Chin's brutal death in 1982 galvanized the Asian American community into action and set off a series of far-reaching legal reforms.

Vincent Chin was accosted in a Highland Park bar by two unemployed auto workers who blamed him – and all Asians – for their job loss.

The verbal assaults escalated into physical beating, and four days later, on June 23, Vincent Chin died.

Although they pleaded guilty to manslaughter, neither assailant spent a single day in jail and were instead sentenced to three-year probation and a \$3,000 fine.

The charges and the sentence triggered an uproar in the Asian community and prompted its citizenry to organize against the injustice. The first gatherings were held at Vincent Chin's last workplace – the Golden Star Restaurant at 22828 Woodward Avenue, now named Post Bar.

Today, Chin's legacy is a changed legal system regarding sentencing guidelines and victim's rights, and the establishment in 1983 of important

political action groups such as the American Citizens for Justice.

Ferndale Mayor Craig Covey, who led the dedication rites last Dec. 22, commented: “The murder of Vincent Chin was a hate crime made worse by the failure of our legal system to live up to the American promise of justice for all. This memorial symbolizes a shared community value: The People of Ferndale join others in standing up for acceptance, fairness and equality for everyone.”

The State Bar of Michigan presented the 34th Milestone Marker to Ferndale in June of 2009, on behalf of the State Bar and the Michigan Asian Pacific American Bar Association.

The official dedication ceremonies were held at noon of last Dec. 22 at Post Bar.
